

## TO: ALL STOCKHOLDERS WITH DELINQUENT SHARES

Notice is hereby given that during its regular meeting held on 5 August 2021, the Board of Directors of **AyalaLand Logistics Holdings Corp.** (formerly Prime Orion Philippines, Inc.)
